

Civis Analytics fielded a survey with 762 Florida respondents on September 17-21, 2020. Below are some key takeaways from this wave's research.

## Florida Highlights

### School Reopenings

As schools reopened around the country, we continued polling about parent and school actions. 45.0% of parents of K-12 students in Florida say that they have disenrolled their children from the school they were originally supposed to attend this year in response to school reopening plans, compared to 37.3% of Florida parents in mid-August. This is also higher compared to the 38.1% of parents across the US who say that they have disenrolled their children. Of those Florida parents that disenrolled their children, 55.2% enrolled their child or children in an online program, 25.8% enrolled in a public school, and 23.4% enrolled in a private school. 74.5% of Florida parents who disenrolled their children say that they will re-enroll their children back into the original school once it is safe to do so, slightly up from the 71.2% of Florida parents who said in mid-August that they would re-enroll their children into the original school.

34.7% of Florida parents of K-12 students report that their children are attending all in-person classes, 55.2% report that their children are attending all remote classes, and 10.0% report a hybrid of in-person and remote.

Most Florida parents of K-12 students would be more willing to send their children to school if safety measures are taken (between 50.0% - 61.1% for each measure), and even more think that their children's schools have been able to implement those measures at least somewhat successfully (between 64.6% - 79.2% for each measure). The safety measures that Florida parents believe their children's schools have been the most successful in implementing are requiring sick students and staff to stay home (79.2%), providing masks and hand sanitizer (79.2%) and increasing cleaning and disinfecting of facilities (78.8%). Those same safety measures that Florida parents report as being at least somewhat successful align with those that they thought would be the most likely to be successful when asked in the last wave.

Also of interest, 14.9% of Florida parents say that they would be *less willing* to send their children to school if a measure to reduce the hours per day that a student is at school is implemented.

**Postsecondary Education Transitions**

We have also continued polling about postsecondary plans of high school seniors as they returned to school. 78.5% of Florida parents of high school seniors report that their child is planning to apply to four-year colleges this fall, compared to 64.3% of parents of high school seniors in mid-August; of those, 64.7% say they and their child feel ‘Very prepared’ to navigate the college financial aid process, compared to 6.7% who feel ‘Not at all prepared.’ 75.3% of Florida parents of high school seniors say that their child has been in touch with a school guidance counselor to make plans for after graduation, compared to 56.2% of parents of high school seniors in mid-August. This is slightly less than 78.8% of parents of high school seniors across the US.


## Attitudes toward Coronavirus

### How concerned are you about Coronavirus (COVID-19)?

Overall, 43.7% of Florida adults say that they are 'Very concerned' about Coronavirus (COVID-19), down slightly from 46.7% reported in the last wave of research in August. Concern has remained fairly steady in Florida since mid-May.

#### Attitudes Concern Level in FL

Question Text: "How concerned are you about Coronavirus (COVID-19)?"



53.1% of Florida adults are more concerned than before due to COVID-19 cases increasing in some areas, particularly around college campuses, compared to 41.3% who have maintained the same concern level and 5.0% who are less concerned than before. 38.1% of adults in Florida believe students being irresponsible and not following guidelines set by their college or university is the most important factor contributing toward the increase in COVID-19 cases around college campuses, followed by the federal government not setting appropriate guidelines for all campuses to follow (15.1%) and college universities not putting into place necessary precautions for students to return to campus (14.3%).

These reactions are somewhat similar to the reactions to surges in certain states last month, when Florida adults most commonly said the most important factor is people living in those states not following guidelines for social distancing and wearing masks in public. The other top reported factors were state governments choosing to reopen too quickly and the federal government not setting appropriate guidelines for all states to follow.

As with all waves since late-June, many Florida adults (41.5% in this wave) continue to wish that their state would do even more about closures, restrictions and other steps to slow the spread of the virus.

Overall, Florida adults continue to be largely in favor of preventative measures. 79.2% agree that social/physical distancing and shelter-in-place orders have been successful in slowing the spread of COVID-19 and 86.3% agree that social/physical distancing is difficult by worth it, while only 36.2% say they want to get back to normal, even if it means risking another outbreak.

In terms of coping behaviors, Florida adults have, on average, spent time on social media on 4.0 days in the last week, made time to relax on 3.8 days in the last week, and connected with family friends on 3.7 days in the last week. 81.1% of Floridians have shopped for groceries at least once a week, whereas 7.5% have not left their home for grocery shopping in at least two weeks. This level of activity is up from activity in mid-April (66.7% of Floridians buying groceries outside at least once a week), when most shelter-in-place orders were active. 50.6% of Floridians have gone out for take-out at least once a week, whereas 24.9% have not left their home for take-out in at least two weeks. This level of activity is up from activity in mid-April (39.1% of Floridians leaving their home at least once a week for take-out), when most shelter-in-place orders were active.

**Methodology:** Responses were gathered through online web panels and weighted to accurately reflect the entire adult population of Florida. Questions were fielded September 17-21, 2020 (762 respondents).
